### MBBS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA 2023-24

#### NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR STRAY VACANCY PHASE OF COUNSELING FOR MBBS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA

In continuation to this office notifications dated: 06.07.2023, 26-07-2023, 02-08-2023 , 03-08-2023, 29-08-2023 and 09-09-2023 KNRUHS hereby notifies the conduct of Stray vacancy phase of web based counseling for allotment vacant seats after Mop up phase of counseling for MBBS course under Competent Authority Quota for 2023-24.

**All the eligible candidates whose names are displayed in the Provisional final merit list on KNRUHS website who were not allotted any MBBS seats in the previous phases of counseling can exercise web options 04.00 P.M. on 25.09.2023 to 4.00 P.M. on 26.09.2023 through website <https://tsmedadm.tsche.in/> from computer with internet connection subject to fulfillment of the following conditions.**

1. Candidates who were allotted seats in the previous phases of counseling and joined the course (CQ and MQ) for MBBS are not eligible to exercise web options.
2. Candidates who were allotted seats in the previous phases of counseling and have not reported/discontinued the course (CQ) for MBBS at the respective college are not eligible for exercising options.
3. Candidates who have not exercised web options in the previous phases of counseling (CQ) for MBBS are also not eligible to exercise web options.
4. Candidates who are admitted in MBBS/BDS courses under All India Quota Counseling as notified by MCC/ Dr.YSRUHS (Dr.NTRUHS) counselings (CQ and MQ) are not eligible to exercise web options.
5. Any candidate who is admitted into MBBS course in any medical college is advised not to exercise web options as it amounts to seat blocking.

6. If any candidate violates this and the same is noticed by the University at any stage/at a later date, the admission stands cancelled automatically and the candidate is liable for punishment as per law .

For eligibility criteria and regulations refer to notifications dated: 10.10.2022.

**UNIVERSITY FEE:** Allotted Candidates have to pay University fee of Rs. 12,000/- for MBBS Course through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter.

**TUITION FEE:** Tuition fee is to be paid at respective Medical colleges as follows.

MBBS	Government Medical Colleges	10,000/- Per year.
	Private Non-Minority/Minority/ESI Medical Colleges	60,000/- per year.

**NOTE:**

1. The details of vacant seats available (seat matrix) are placed in the website <http://knruhs.telangana.gov.in> . Candidates can exercise web options for MBBS seats in all Medical colleges affiliated to KNRUHS through <https://tsmedadm.tsche.in/>.
2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017, subsequent amendments, G.O. Ms. No. 125, Health, Medical and Family Welfare (C1) Department Dated: 22.09.2022, G.O. Ms. No. 72, Health, Medical and Family Welfare (C1) Department Dated: 03-07-2023 , G.O. Ms. No. 75, Health, Medical and Family Welfare (C1) Department Dated: 04-07-2023 and relevant Hon'ble High Court/Supreme court orders and University regulations,
3. Candidates are advised to go through the Prospectus and the Government Orders on Rules of UG admissions available on website before exercising web options.

4. Competent Authority Quota seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Competent Authority Quota seats in other Medical Colleges.

**IMPORTANT INSTRUCTIONS TO THE CANDIDATES:**

- 1) Eligible NEET-UG-2023 qualified candidates as per provisional final merit list for Competent Authority Quota can exercise web options for vacant MBBS seats in Medical colleges as per their interest and priority through <https://tsmedadm.tsche.in> from computer with internet connection.
- 2) Candidates exercising web-options for MBBS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of colleges the candidate is interested to join as per candidate's eligibility and vacancies.
- 3) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z.
- 4) Candidates are instructed to take a print out of saved options.
- 5) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also informed to login to check their allotment status on <https://tsmedadm.tsche.in> website after each phase of counseling.
- 6) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using Online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of respective college on or before the date specified on the allotment letter.

- 7) Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and the candidate will be considered as being part of seat blocking and candidate has to pay penalty of Rs. 20 lakhs and also debarred for 3 years for MBBS admission under KNRUHS to prevent seat blocking.
- 8) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
- 9) **Candidates have to compulsorily join at the allotted college without fail in this phase of counseling. Failure to join the course will be considered as being part of seat blocking and candidate has to pay penalty of Rs. 20 lakhs and also debarred for 3 years for MBBS admission under KNRUHS to prevent seat blocking.**
- 10) Candidates are informed that as per Hon'ble Supreme Court orders and in accordance with GO.Ms.No. 125 HM & FW Department, dated. 22.09.2023, admitted candidates are not permitted to withdraw from the course.
- 11) Admitted candidates will have to pay discontinuation penalty amount of Rs.20 lakhs as per Government Orders, if they discontinue the course after the Stray vacancy phase of counseling to get their original certificates back. **Candidates also will be debarred for 3 years for MBBS admission under KNRUHS to prevent seat blocking.**
- 12) **In the event of any seats remaining vacant due to non-joining of candidates in the stray vacancy phase of counseling, the vacant seats shall be allotted in accordance with the options exercised by the candidates in this stray vacancy phase without issuing any fresh notification.**

**13) The University fee once paid shall not be refunded under any circumstances.**
