NOTIFICATION FOR ONLINE REGISTRATION FOR ADMISSIONS INTO MSc (NURSING) COURSES UNDER COMPETENT AUTHORITY QUOTA FOR 2023-24 IN THE STATE OF TELANGANA

Application forms online are invited from the eligible candidates for admission into MSc (Nursing) courses under Competent Authority Quota for the academic year 2023-24 in Colleges affiliated to Kaloji Narayana Rao University of Health Sciences, Telangana State.

- 1 Candidates can apply for admission into MSc (Nursing) Courses through online on the Website <https://tspgparamed.tsche.in/> from 8.00 AM 01.10.2023 to 6.00 PM on 07.10.2023. The online application can be filled through any computer with internet connection.
- 2 For other details read the Prospectus carefully. The Prospectus of the course, Instructions for filling online application is available on the University Website / <http://knruhs.telangana.gov.in>
3. **Eligibility for admission into MSc (Nursing) Courses**

Candidate should be Indian National and should satisfy Local / Non-Local status as per G.O.P.NO. 646 Education Department Dated: 10-07-1979. Please refer to Prospectus for details.

3.1 QUALIFICATION & EXPERIENCE:

Candidates should have passed B.Sc., (N) 4YDC / Post BSC (N) 2YDC) degree from an Institution, which is recognized by Indian Nursing Council. Candidates shall secure minimum of 55% of aggregate marks for OC category and minimum of 50% of aggregate marks for BC, SC and ST categories.

For Service Quota seats at Government College of Nursing, Hyderabad, Candidates who are in Government service are only eligible for admission, subject to fulfillment of Government Orders from time to time.

3.2 EXPERIENCE:

a) For Service Quota seats :-

Should be a Regular Government Employee and shall have put in not less than 5 years service in the departments of Medical & Health Service, Vaidya Vidhana Parishad as on 30-09-2023. Service certificate shall be issued by the Director of Public Health/DME/Commissioner VVP.

b) For Non-service Quota seats :-

i) For Regular candidates, minimum one year of work experience after registration of B.Sc., (N) course as on 30-09-2023.

ii) Minimum one year of work experience prior or after registration of Post Basic Nursing courses as on 30-09-2023.

4. a) Merit list will be finalized taking into consideration the aggregate percentage of marks obtained by the candidate in BSc(N) 4 YDC / PB. BSc(N) 2 YDC in all subjects.

b) In case of equality of marks percentage, Date of Birth shall be taken in to consideration and candidate born earlier will be considered first.

c) In case of equality of age also aggregate marks percentage of final year exam obtained by candidate will be taken into consideration.

5. Registration and Verification Fee:-

The Registration and Verification fee is Rs.5,000/- + Bank Charges for OC and BC and Rs.4,000/- + Bank charges for SC/ST category candidates. Fee shall be paid online through Debit card / Credit card or Net Banking.**

6. Candidates who studied BSc(Nursing) in colleges outside the state of Telangana and Andhra Pradesh are required to pay Rs.3000/- towards Degree Equivalency Verification fee In addition to Registration fee.

**** Registration and verification fee once paid is not refundable.**

7. Process of online application and uploading :-

While filling the On-line application form keep all the mandatory Certificates with you to enter the details required to determining the Merit position. Applications without photo, signature at declaration area, incomplete applications will be automatically rejected and will not be considered for determining the Merit position in respective categories.

CHECK LIST FOR APPLICATION FOR ON-LINE REGISTRATION & UPLOADING

The following Documents are required for filling and have to be uploaded along with application form

- A. Passport size Photograph Self Attested.
- B. Aadhaar card
- C. Signature in the declaration area.
- D. Marks statements from 1st BSc (N)4YDC/2YDCto Final BSc(N) 4YDC/2YDCcourse.
- E. Experience Certificate mentioning date of commencement and completion.
- F. Provisional or Original BSc(N) 4YDC/2YDC Degree Certificate.
- G. Study Certificate from 10th to Intermediate.
- H. Study certificate of BSc (N)4YDC/2YDC Course.
- I. Permanent Caste Certificate (as in the application form proformag) Discontinuance certificate
- J. EWS Certificate valid for the year 2023-24.
- K. Candidates claiming eligibility about local/non-local should furnish relevant certificates in support of their claim.
- L. Candidates who have studied in the state of Telangana / Andhra Pradesh.
 - i. if the candidate has studied in any educational institution, study/Bonafide certificate from VI to Intermediate (Govt. ZPH/Private School or College) shall be submitted.
 - ii. A candidate who has studied in 2 or more institutions in various place in Telangana / Andhra Pradesh, study Bonafide certificate from VI to intermediate (Govt/ZPH/Private School or College) in those places shall be submitted.
 - iii. A candidate who has not studied a class in any school / institution, a residence certificate for that period only shall be submitted.
 - iv. Candidate who have not studied in any school/ college in the state of Telangana / A.P., but resided in Telangana / Andhra Pradesh with private study in Telangana / Andhra Pradesh seven years residence certificate mentioning the period of residence preceding the qualifying examination (6th to Inter) by the candidate claiming eligibility as a local be virtue of residence shall be submitted.
- l) Candidates who have studied in the institutions outside the State of Telangana / Andhra Pradesh have to submit 10 years residence certificate of the either of the parents or the candidate (excluding the period of B.Sc. Nursing course) issued by MRO to claim seats under unreserved category.
- m) For Service candidates Service certificate issued by DME/DPH/Commissioner VVP

8. **Tuition Fee:** as notified by the Government of Telangana.

9. **The candidate should submit the print-out of the filled in online application form along with 1-set of self attested copies of required certificates along with the Original Certificates at the time of admission.**

- 10. The Orders issued from time to time by Government with regard to Admissions shall apply.**
- 11. Final merit list will be notified after verification of uploaded Original certificates.**
- 12. All further notifications will be notified on KNRUHS web-site. No individual intimation will be sent.
