MBBS ADMISSIONS UNDER MANAGEMENT QUOTA 2024-25

Notification for exercising web-options for Mop Up phase of counseling

In continuation to this office notifications dated: 17-08-2024, 27-09-2024, 29-09-2024, 03-10-2024, 07-10-2024 and 22-10-2024, KNRUHS hereby notifies the conduct of Mop Up phase of web-based counseling for vacant seats after second phase for admission into MBBS courses under Management Quota for 2024-25 in affiliated Private Medical Colleges, Neelima Institute of Medical Sciences affiliated to Anurag University and **newly sanctioned seats at Nova Institute of Medical Sciences, Hayathnagar.**

Candidates who are notified in the provisional final merit list of MBBS/BDS Admissions under Management Quota (29-09-2024) and subsequent Addendum /Corrigendum notified on the KNRUHS website are eligible to exercise web - options online from computer with internet connection.

All the eligible candidates whose names are displayed in the Provisional final merit list for Management Quota on KNR UHS website can exercise web options for admission into MBBS courses from 7.00 AM on 23.10.2024 to 8.00 PM on 23.10.2024 through https://tspvtmedadm.tsche.in/ as per the candidate registration and eligibility for B & C (NRI) categories subject to following conditions:

- The Candidates who were allotted seats in the previous phases of counseling under Management Quota and have not reported/discontinued the MBBS course at the respective college are not eligible for exercising options for MBBS course.
- **2.** Candidates who have not exercised web options in the first phase of counseling for MBBS course under Management Quota are not eligible to exercise web options for that course.
- **3.** Candidates whose names are notified in the college wise allotment list of MBBS course under Competent Authority Quota after Mop Up Phase of Counselling on KNRUHS website are not eligible to exercise web-options.

- **4.** Candidates who have joined MBBS course under Management Quota in the first phase and continuing in the course are eligible to exercise web options and are informed to exercise web options.
- **5.** Candidates who are admitted under MCC Counselling up to third phase of counselling as notified on MCC website are not eligible to exercise weboptions.

Candidates will have to exercise web options for the MBBS seats in order of preference for colleges and category (B&C/NRI).

For eligibility criteria and regulations refer to notifications dated: 17.08.2024

UNIVERSITY FEE:

Allotted Candidates have to pay the following University fee through payment gate-way by using online payment method (Debit Card/Credit Card/Internet Banking) and down-load the allotment letter. Candidates who have paid University fee in the previous phases need not pay again.

For B- Category:

For C-Category (NRI):

1) MBBS Rs. 40,000=00

1) MBBS Rs. 70,000=00

TUITION FEE: Tuition fee is to be paid at respective Medical colleges.

- The tuition fee payable as notified by Government of Telangana in GO Ms No:106, HM& FW (C1) Department, Dated:28. 07.2023 (notified on KNRUHS web site) and G.O.Ms.No.132 HM&FW Dept Dated:18.08.2023 for Deccan College of Medical Sciences.
- 2. For Neelima Institute of Medical Sciences: Tuition Fee Rs:15 lakhs per annum for B Cat and Rs:22.5 lakhs per annum for C/NRI Cat as per G.O.Ms.No 40, Higher Education (UE) Dept Dated:20.06.2023

NOTE:

- 1) The details of vacant seats and newly added seats of Nova Institute of Medical Sciences, Hayathnagar (seat matrix) are placed in the website http://knruhs.telangana.gov.in Candidates can exercise web options for MBBS all Medical Colleges KNRUHS through seats in under https://tspvtmedadm.tsche.in/
- 2) In accordance with the GO.Ms.No.130 HM&FW (C1) Department, Dated: 27.09.2022 in Management Quota B Category, 85% of seats are reserved for local candidates of Telangana and 15% seats are open to candidates from all over the country. 15% unreserved seats shall be allotted first followed by seats reserved for local

candidates in Management Quota B category seats.

- 3) The MBBS seats in Neelima Institute of Medical Sciences are distributed in accordance with the "Telangana State Private Universities (Establishment and Regulation) Act", Act no. 11 of 2018
- 4) The allotment of seats will be made in accordance with the selection procedure notified in Government Orders G.O.Ms.No. 115 & 116 HM&FW (C1) Dept. Dated: 05-07-2017, G.O.Ms.No.117 & 118 HM&FW(C1)Dept. Dated: 20-07-2017, subsequent amendments, G.O.Ms.No.125, 126, 127, HM&FW (C1), Department, Dated:22-09-2022, GO.Ms.No.130 HM&FW (C1) Department, Dated:27.09.2022, G.O.Ms.No.33 HM&FW (C1) Department (for Local area), Dated: 19.07.2024, other Government orders, University Regulations and relevant Hon'ble Supreme Court and High Court orders.
- 5) Candidates are informed that they will be considered only to the category / categories to which they have registered. (B/NRI)
- 6) Admitted candidates are not permitted to withdraw/discontinue from the course after Mop up phase of counseling. Admitted candidates will have to pay discontinuation penalty amount of Rs.20 lakhs as per Government Orders, if they discontinue the course after the Mop up phase of counseling to get their original certificates back. Candidates also will be debarred for 3 years for MBBS admission under KNRUHS to prevent seat blocking
- 7) Candidates are informed that the allotments/admissions are subject to Orders of Hon'ble Courts in all pending cases.

IMPORTANT INSTRUCTIONS TO CANDIDATES:

- 1) Eligible NEET-UG-2024 Candidates as per Provisional Final Merit List for Management Quota can exercise web options for vacant seats under Management Quota in all Medical colleges as per their interest and priority from computer with internet connection through https://tspvtmedadm.tsche.in/
- **2)** Candidates are advised to go through the Prospectus for the Regulations for MBBS/BDS courses under Management Quota of KNRUHS, available on website before exercising web options.
- 3) If a candidate is allotted a seat in MBBS course as per his/her options and does not join the course, penalty clause shall be applicable including penalty amount of Rs. 20.00 lakhs and debarment for 3 years to prevent

- seat blocking. If candidates are not interested to join in any college they should not exercise web options for the same.
- 4) Candidates are advised to exercise web options for MBBS seats in all colleges in which they are interested to join irrespective of available vacant seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in previous phases of counseling to other seats as per their web options in the Mop Up phase of counseling.
- by the candidate in this phase of counseling as per web options exercised by the candidate in this phase of counseling, the seat allotted in previous phases of counseling will be automatically cancelled and allotted to the other candidate. Therefore, candidates are informed to exercise web options carefully for sliding with awareness of this fact.
- 6) Candidates exercising web-options for MBBS courses are informed that there is no limit of choices (number) for exercising web-options. Candidates have to exercise web options for any number of courses/colleges the candidate is interested to join as per candidates eligibility (B/C-NRI) in order of preference.
- 7) Management Quota B &C (NRI) seats in Un-aided Private Minority Medical Colleges are reserved for Muslim Minority Candidates only. In case Muslim Minority Candidates are not available the seats may be filled up with Non Minority students up to maximum of 30% during this phase of counseling.
- **8)** Candidates have to exercise options for B category and if eligible for C (NRI) in order of their priority for course and college. Allotments will be made according to the order of preference in the web options exercised by the candidate.
- 9) Candidates can exercise options on the web either from home / any other place having internet facility. Candidates are instructed to take a print out of saved options
- **10)** One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options.
- **11)** Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are directed to login to check their allotment status on through https://tspvtmedadm.tsche.in/ website after each phase of counseling without fail.

- 12) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using online payment method (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment details and report to the Principal of respective Medical college on or before the date specified on the allotment letter.
- before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and penalty clause shall be applicable including penalty amount of Rs. 20.00 lakhs and debarment for 3 years to prevent seat blocking.
- 14) If the candidate slides to other college during Mop up phase of counseling in Medical colleges affiliated to KNRUHS, the original certificates will be sent to the Medical college concerned after the closure of admissions. Candidates have to get relieved from previous phase joined Medical college, obtain custodian certificate, collect fees and report to the Principal of allotted Medical college before last date of joining. Admitted candidates shall not be permitted to discontinue from the course after allotment in Mop Up phase of Counselling
- **15)** Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.
- **16)** Candidates allotted seat under NRI Quota should produce the relevant sponsorship letter from NRI relative in Original along with copy of passport/ Residence Proof/Bank Statement or pass book of sponsor for NRI Category at respective colleges.
- 17) In accordance with the clause for upgradation notified by MCC in the Information Bulletin, candidates admitted up to second round shall be permitted to exercise web options for upgradation to Mop Up round of Counselling. Admitted candidates are not permitted to withdraw from the course after Mop Up phase of counselling.
- 18) Original certificates submitted at the time of admissions shall not be returned to candidate, unless the candidate discontinues the course.

19) The University fee once paid shall not be refunded under any circumstances.
