BDS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA 2024-25

NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR STRAY VACANCY PHASE OF COUNSELING

In continuation to this office notifications dated: 03-08-2024, 12-08-2024 and 27-08-2024, 21-09-2024, 24-09-2024, 26-09-2024, 28-09-2024, 07-10-2024, 22-10-2024 and 29-10-2024 Kaloji Narayana Rao University of Health Sciences hereby notifies the conduct of Stray Vacancy phase of web based counseling for vacant seats after Mop Up phase for admission into BDS courses under Competent Authority Quota (C.Q) for for 2024-25 in Government, Private Dental Colleges and Army Dental College in the State of Telangana.

Candidates whose names are notified as eligible candidates in the provisional final merit list of MBBS/BDS Admissions on the KNRUHS website on 26-09-2024 and addendums are eligible to exercise web - options online from computer with internet connection.

All the eligible candidates whose names are displayed in the Provisional final merit list including PWD, PMC, Anglo-Indian and CAP category candidates and addendums on KNRUHS website can exercise web options for admission into BDS seats from **3.00 PM on 30.10.2024 to 3.00 PM on 31.10.2024** through website <https://tsbdsadm.tsche.in/> subject to following conditions:

1. The Candidates who were allotted seats in the previous phases of counseling under Competent Authority Quota are not eligible for exercising options.
2. Candidates who have not exercised web options in the first phase of counseling under Competent Authority Quota are not eligible to exercise web options.
3. Candidates who have joined BDS course under Management Quota in the previous phases and continuing in the course are not eligible to exercise web options.
4. Candidates who are admitted into MBBS course under Competent Authority Quota and Management Quota under KNRUHS are not eligible to exercise

web options.

5. Candidates who are admitted under MCC Counselling up to third phase of counselling as notified on MCC website are not eligible to exercise web-options.
6. Options of candidates who are admitted in other states as per the data uploaded to MCC portal shall not be considered.
7. Options of candidates who are allotted seats in the Stray Vacancy round of MCC Counseling shall not be considered.

For eligibility criteria and regulations refer to notifications dated: 03.08.2024.

UNIVERSITY FEE:

Allotted Candidates have to pay University fee of Rs. 12,000/- for BDS Course through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter.

TUITION FEE:

Tuition fee is to be paid at respective Dental colleges.

Tuition fee payable is as notified by Government

NOTE :

1. The details of vacant seats available (seat matrix) are placed in the website <http://knruhs.telangana.gov.in> . Candidates can exercise web options for BDS seats in all Dental colleges affiliated to KNRUHS through <https://tsbdsadm.tsche.in/>
2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017, subsequent amendments, G.O. Ms. No. 125, Health, Dental and Family Welfare (C1) Department Dated: 22.09.2022, G.O. Ms. No. 75, Health, Dental and Family Welfare (C1) Department Dated: 04-07-2023, G.O. Ms. No. 33, Health, Dental and Family Welfare Admitted candidates are not permitted to withdraw/discontinue from the course after Mop up phase of counseling.

3. Candidates are informed that the allotments/admissions are subject to Orders of Hon'ble Courts in all pending cases.

IMPORTANT INSTRUCTIONS TO THE CANDIDATES:

- 1) Eligible NEET-UG-2024 qualified candidates as per provisional final merit list for Competent Authority Quota can exercise web options for BDS seats in Dental colleges as per their interest and priority through <https://tsbdsadm.tsche.in/> from computer with internet connection subject to above stated conditions.
- 2) Candidates are advised to go through the Prospectus for the Regulations for MBBS/BDS course on KNRUHS website before exercising web-options.
- 3) Admitted candidates will have to pay discontinuation penalty amount of Rs.20 lakhs as per Government Orders, if they discontinue the course after the Mop up phase of counseling to get their original certificates back. Candidates also will be debarred for 3 years for BDS admission under KNRUHS to prevent seat blocking.
- 4) If a candidate is allotted a seat in BDS course as per his/her web-options in this phase and does not join the course, penalty clause shall be applicable including penalty amount of Rs. 20.00 lakhs and debarment for 3 years to prevent seat blocking.
- 5) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read construction to the candidates before giving options)
- 6) Candidates are instructed to take a print out of saved options.
- 7) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are directed to login to check their allotment status on <https://tsbdsadm.tsche.in/> website after each phase of counseling without fail.
- 8) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of respective

Dental College on or before the date specified on the allotment letter.

- 9) Selected candidates have to report to the Principal of the respective Dental College before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and penalty clause shall be applicable including penalty amount of Rs. 20.00 lakhs and debarment for 3 years to prevent seat blocking.
- 10) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted Dental College and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
- 11) Admitted candidates shall not permitted to discontinue the course after allotment in Mop Up phase of Counselling
- 12) **The University fee once paid shall not be refunded under any circumstances.**
