MBBS ADMISSIONS UNDER MANAGEMENT QUOTA 2022-23

NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR STRAY VACANCY

PHASE OF COUNSELING

In continuation to this office notifications dated 19.10.2022, 07.11.2022, 10.11.2022, 30-11-2022 and 12-12-2022 Kaloji Narayana Rao University of Health Sciences hereby notifies the conduct of Stray Vacancy Phase of web-based counseling for vacant seats after Mop-up phase of counseling for MBBS courses under Management Quota for 2022-23 in un-aided Private Non-Minority/Minority Medical Colleges in the state of Telangana.

All the eligible candidates whose names are displayed in the Provisional final merit list for Management Quota on KNRUHS website and addendums, who were not allotted any seats in the previous phases of counseling can exercise web options from **10.00 AM on 22.12.2022 to 2.00 PM on 23.12.2022** through website <https://tspvtmedadm.tsche.in/> as per the candidates registration and eligibility for B & C (NRI) categories subject following conditions.

1. The candidates who were allotted seats in the previous phases of counseling and joined the course under Competent Authority Quota (CQ) or Management Quota (MQ) for MBBS and BDS courses are not eligible to exercise web options.
2. The Candidates who were allotted seats in the previous phases of counseling under Management Quota for MBBS course and have not reported/discontinued the course at the respective college are not eligible for exercising options.
3. Candidates who have not exercised web options in the previous phases of counseling of Management Quota for MBBS course are also not eligible to exercise web options.

4. Candidates who are admitted into MBBS and BDS courses in All India Quota Counseling as notified by MCC, any counselings in other states and Mop Up phases of Dr.YSRUHS (Dr.NTRUHS) counselings (CQ and MQ) are not eligible to exercise web options.
5. Candidates who are allotted MBBS seats in Stray vacancy counseling of All India Quota will not be considered for allotment in Stray vacancy round of KNRUHS (options exercised will not be considered) to prevent seat blocking.
6. If any candidate violates this and the same is noticed by the University at any stage/at a later date, the admission stands cancelled automatically and the candidate is liable for punishment as per law.

For eligibility criteria and regulations refer to notifications dated: 19.10.2022.

UNIVERSITY FEE: Allotted Candidates have to pay the following University fee through payment gate-way by using online payment method (Debit Card/Credit Card/Internet Banking) and down-load the allotment letter.

For B- Category :

MBBS Rs. 40,000=00

For C-Category (NRI):

MBBS Rs. 70,000=00

TUITION FEE: Tuition fee is to be paid at respective Medical colleges. The tuition fee payable as notified by Government of Telangana in GO Ms No:5, HM&FW (C1)Department, Dated:27. 01.2022 (notified on KNRUHS web site)

NOTE:

- 1) The details of vacant seats are placed in the website <http://knruhs.telangana.gov.in> . Candidates can exercise web options for vacant MBBS seats in all Medical Colleges under KNRUHS through <https://tspvtmedadm.tsche.in/>.
- 2) In accordance with the GO.Ms.No.130 HM&FW (C1) Department, Dated:27.09.2022 in Management Quota B Category 85% of seats are reserved for local candidates of Telangana State and 15% seats are open to candidates from all over the country. 15% unreserved seats shall be allotted first followed by seats reserved for local candidates in Management Quota B category seats
- 3) The allotment of seats will be made in accordance with the selection procedure notified in Government Orders G.O.Ms.No. 115 & 116 HM&FW (C1) Dept. Dated:

05-07-2017, G.O.Ms.No.117 & 118 HM&FW(C1)Dept. Dated: 20-07-2017, subsequent amendments, G.O.Ms.No.125, 126, 127, HM&FW (C1) , Department, Dated:22-09-2022, GO.Ms.No.130 HM&FW (C1) Department, Dated:27.09.2022, other Government orders, University regulations and relevant Hon'ble Supreme Court and Hon'ble High Court orders.

- 4) Candidates are advised to go through the Prospectus and the Government Orders on Rules of UG admissions available on website before exercising web options for the regulations.
- 5) Candidates are informed that they will be considered only to the category / categories to which they have registered.(B/NRI), eligible and notified on website in the merit list.

IMPORTANT INSTRUCTIONS TO CANDIDATES:

- 1) Eligible NEET-UG-2022 qualified candidates as per Provisional Final Merit List for Management Quota can exercise web options for vacant Management Quota MBBS seats in all Medical colleges as per their interest and priority from computer with internet connection through <https://tspvtmedadm.tsche.in/>
- 2) Candidates exercising web-options for MBBS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for vacant seats in any number of colleges the candidate is interested to join as per candidate's eligibility and registration. If candidates are not interested to join in any college they should not exercise web options for the same.
- 3) Management Quota B &C (NRI) seats in Un-aided Minority Medical Colleges are reserved for Muslim Minority Candidates only. Any seats left over at the end of the counseling shall be allotted to Non-Minority candidates.
- 4) Candidates have to exercise options for B category and if eligible for C (NRI) in order of priority for course and college. Allotments will be made according to the order of preference in the web options exercised by the candidate.

- 5) Candidates can exercise options on the web either from home / any other place having internet facility. Candidates are instructed to take a print out of saved options
- 6) One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options.
- 7) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also directed to login to check their allotment status on through <https://tspvtmedadm.tsche.in/> website after each phase of counseling without fail.
- 8) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using online payment method (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment details and report to the Principal of respective college on or before the date specified on the allotment letter , submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission.
- 9) Candidates who have deposited their original certificates and tuition fee with University at the time of registration shall report with allotment letter, receipt of certificates and tuition fee to the Principal to complete the process of admission following due procedure. The original certificates and tuition fee shall be transferred to the colleges by the University.
- 10) Candidates who have deposited tuition fee as per the orders of the Hon'ble High Court have to report to the Principal with allotment letter, submit all original certificates, bonds to complete the process of admission following due procedure. The tuition fee shall be transferred to the colleges by the University.
- 11) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.

- 12) Candidates allotted seat under NRI Quota should produce the relevant sponsorship letter from NRI relative in Original along with copy of passport/ Residence Proof/Bank Statement or pass book of sponsor for NRI Category at respective colleges.
- 13) Candidates have to compulsorily join at the allotted college in the allotted course without fail in this phase of counseling. Failure to join the course will be considered as being part of seat blocking with penalty amount of 20 lakhs is applicable and candidates will be debarred for MBBS admissions under KNRUHS for 3 years.
- 14) Admitted candidates will have to pay discontinuation penalty amount of Rs.20 lakhs as per Government Orders, if they discontinue the course after the second phase of counseling to get their original certificates back. Candidates also will be debarred for 3 years for MBBS admissions under KNRUHS to prevent seat blocking.
- 15) The University fee once paid shall not be refunded under any circumstances.
