BDS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA 2023-24

NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR FIRST PHASE COUNSELING OF BDS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA IN AFFILIATED GOVERNMENT, PRIVATE DENTAL COLLEGES AND ARMY DENTAL COLLEGE.

In continuation to this office notifications dated: 06.07.2023, 26-07-2023 and 02-08-2023 Kaloji Narayana Rao University of Health Sciences hereby notifies the conduct of first phase of web based counseling under Competent Authority Quota (C.Q) for BDS course including EWS, PWD, Anglo Indian, CAP categories for 2023-24 in Government, Private Dental Colleges and Army Dental College in the State of Telangana.

Candidates whose certificates were uploaded at the time of online registration and provisionally verified by staff of concerned departments and whose names are notified as eligible candidates in the provisional final merit list of UG Admissions on the KNRUHS website are eligible to exercise web - options online from computer with internet connection.

All the eligible candidates whose names are displayed in the Provisional final merit list including PWD, Anglo Indian, CAP categories and EWS quota candidates on KNRUHS website can exercise web options for admission into BDS seats from 10.00 A.M. on 24.08.2023 to 02.00 P.M. on 26.08.2023 through website https://tsbdsadm.tsche.in/

For eligibility criteria and regulations refer to notifications dated: 06.07.2023.

UNIVERSITY FEE: Allotted Candidates have to pay University fee of Rs. 12,000/- for BDS Course through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter.

TUITION FEE: Tuition fee is payable as notified by Government

NOTE:

- The details of seats available (seat matrix) are placed in the website http://knruhs.telangana.gov.in. Candidates can exercise web options for BDS seats in all Dental colleges affiliated to KNRUHS through https://tsbdsadm.tsche.in/.
- 2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017, subsequent amendments, G.O. Ms. No. 125, Health, Dental and Family Welfare (C1) Department Dated: 22.09.2022, G.O. Ms. No. 72, Health, Dental and Family Welfare (C1) Department Dated: 03-07-2023, G.O. Ms. No. 75, Health, Dental and Family Welfare (C1) Department Dated: 04-07-2023 and relevant Hon'ble High Court/Supreme court orders and University regulations,
- 3. Candidates are advised to go through the Prospectus and the Government Orders on Rules of UG admissions available on website before exercising web options.
- 4. IMPORTANT NOTE: CANDIDATES ARE INFORMED THAT IF THEY EXERCISE WEB- OPTIONS FOR A SEAT AND ALLOTTED A BDS SEAT AS PER THEIR CHOICE IN THE WEB- COUNSELING AND IF THEY DO NOT JOIN THE COURSE AT THE ALLOTTED COLLEGE, THEY WILL NOT BE ELIGIBLE FOR EXERCISING WEB- OPTIONS FOR SUBSEQUENT ROUNDS OF COUNSELING.

IMPORTANT INSTRUCTIONS TO THE CANDIDATES:

- 1) Eligible NEET-UG-2023 qualified candidates as per provisional final merit list for Competent Authority Quota can exercise web options for BDS seats in Dental colleges as per their interest and priority through https://tsbdsadm.tsche.in/ from computer with internet connection.
- 2) Candidates are advised to go through the Prospectus for the Regulations for BDS course on KNRUHS website before exercising web-options.

- 3) If a candidate is allotted a seat in BDS course as per his/her options and does not join the course, they shall not be permitted to exercise web options in subsequent phases of counselings and admission to prevent seat blocking.
- 4) Candidates exercising web-options for BDS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of colleges the candidate is interested to join as per candidate's eligibility.
- 5) Candidates in the Provisional final merit list are informed that if they do not exercise web options in the first phase of counseling, they are not eligible to exercise web options in subsequent phases of counseling to prevent seat blocking.
- 6) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read construction to the candidates before giving options)
- 7) Candidates are instructed to take a print out of saved options.
- 8) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also informed to login to check their allotment status on https://tsbdsadm.tsche.in/ website after each phase of counseling.
- 9) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using Online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of respective college on or before the date specified on the allotment letter.
- 10) Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within

specified date for joining, the admission will be cancelled automatically and the candidate's options shall not be considered for subsequent phases of counselings and admission to prevent seat blocking.

- 11) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
- 12) Selected candidates have to report at the respective colleges before the last date for joining as specified on the allotment letter, submit all original certificates, the relevant bonds and pay the tuition fee / college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within the specified date, the admission will be cancelled automatically and the candidate will not be permitted to exercise web options for subsequent rounds to prevent seat blocking.
- 13) Original certificates submitted at the time of admissions shall not be returned to candidate, unless the candidate discontinues the course before second phase of counseling.
- 14) The University fee once paid shall not be refunded under any circumstances.
