**NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR FIRST PHASE OF
COUNSELING FOR ADMISSION INTO MBBS/BDS COURSES UNDER
MANAGEMENT QUOTA FOR 2023-24**

In continuation to this office notifications dated 03.08.2023 and 25.08.2023 KNRUHS hereby notifies the conduct of first phase of web-based counseling for admission into MBBS/BDS courses under Management Quota for 2023-24 in affiliated Private Medical/Dental Colleges including Army Dental College and Neelima Institute of Medical Sciences affiliated to Anurag University

Candidates whose certificates were uploaded at the time of online registration and provisionally verified by staff of concerned departments and whose names are notified as eligible candidates in the provisional final merit list of UG Medical/Dental Admissions on the KNRUHS website are eligible to exercise web - options online from computer with internet connection.

All the eligible candidates whose names are displayed in the Provisional final merit list for Management Quota on KNR UHS website can exercise web options for admission into MBBS/BDS courses from 06.00 AM on 26 .08.2023 to 06.00 PM on 28.08.2023 through <https://tspvtmedadm.tsche.in/> as per the candidates registration and eligibility for B & C (NRI) categories.

Candidates will have to exercise web options for the MBBS/BDS seats separately.

For eligibility criteria and regulations refer to notifications dated: 03.08.2023.

UNIVERSITY FEE: Allotted Candidates have to pay the following University fee through payment gate-way by using online payment method (Debit Card/Credit Card/Internet Banking) and down-load the allotment letter.

TUITION FEE: Tuition fee is to be paid at respective Medical/Dental colleges.

1. The tuition fee payable as notified by Government of Telangana in GO Ms No:106, HM& FW (C1)Department, Dated:28. 07.2023 (notified on KNRUHS web site) and G.O.Ms.No.132 HM&FW Dept Dated:18.08.2023(for Deccan College of Medical Sciences.
2. For Neelima Institute of Medical Sciences :Tution Fee Rs:15 lakhs per annum for B Cat and Rs:22.5 lakhs per annum for C/NRI Cat as per G.O.Ms.No 40, Higher Education (UE) Dept Dated:20.06.2023

NOTE:

- 1) The details of seats available (seat matrix) are placed in the website <http://knruhs.telangana.gov.in> . Candidates can exercise web options for MBBS / BDS seats in all Medical / Dental Colleges under KNRUHS through <https://tspvtmedadm.tsche.in/>.
- 2) In accordance with the GO.Ms.No.130 HM&FW (C1) Department, Dated: 27.09.2022 in Management Quota B Category 85% of seats are reserved for local candidates of Telangana State and 15% seats are open to candidates from all over the country. 15% unreserved seats shall be allotted first followed by seats reserved for local candidates in Management Quota B category seats
- 3) The seats in Neelima Institute of Medical Sciences are distributed in accordance with the “Telangana State Private Universities (Establishment and Regulation) Act” ,Act no. 11 of 2018
- 4) The allotment of seats will be made in accordance with the selection procedure notified in Government Orders G.O.Ms.No. 115 & 116 HM&FW (C1) Dept. Dated: 05-07-2017, G.O.Ms.No.117 & 118 HM&FW(C1)Dept. Dated: 20-07-2017, subsequent amendments, G.O.Ms.No.125, 126, 127, HM&FW (C1) , Department, Dated:22-09-2022, GO.Ms.No.130 HM&FW (C1) Department, Dated:27.09.2022, other Government orders, University Regulations and relevant Hon'ble Supreme Court and High Court orders.
- 5) Candidates are advised to go through the Prospectus and the Government Orders on Rules of UG admissions available on website before exercising web options for the regulations.
- 6) **Candidates are informed that they will be considered only to the category / categories to which they have registered.(B/NRI)**

7) IMPORANT NOTE : CANDIDATES ARE INFORMED THAT IF THEY EXERCISE WEB- OPTIONS FOR A SEAT AND ALLOTTED A MBBS/BDS SEAT AS PER THEIR CHOICE IN THE WEB- COUNSELING AND IF THEY DO NOT JOIN THE COURSE AT THE ALLOTTED COLLEGE, THEY WILL NOT BE ELIGIBLE FOR EXERCISING WEB- OPTIONS FOR SUBSEQUENT ROUNDS OF COUNSELING.

Important Instructions to candidates :

- 1) Eligible NEET-UG-2023 Candidates as per Provisional Final Merit List for Management Quota can exercise web options for Management Quota MBBS/BDS seats in all Medical / Dental colleges as per their interest and priority from computer with internet connection through <https://tspvtmedadm.tsche.in/>
- 2) Candidates are advised to go through the Prospectus for the Regulations for MBBS/BDS courses under Management Quota of KNRUHS, available on website before exercising web options.
- 3) If a candidate is allotted a seat in MBBS/BDS course as per his/her options and does not join the course, he/she shall not be permitted to exercise web options in subsequent phases of counselings and admission to prevent seat blocking.
- 4) Candidates exercising web-options for MBBS/BDS courses are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of course/colleges the candidate is interested to join as per candidates eligibility.
- 5) **Candidates in the Provisional final merit list are informed that if they do not exercise web options in the first phase of counseling, they are not eligible to exercise web options in subsequent phases of counseling to prevent seat blocking.**
- 6) Management Quota B & C (NRI) seats in Un-aided Private Minority Medical Colleges are reserved for Muslim Minority Candidates only. In case Muslim Minority Candidates are not available the seats may be filled up with Non Minority students up to maximum of 30% during final Phase of counseling.
- 7) Allotment of Management Quota seats in Army Dental College is reserved for the wards of Army personnel as per AWES Regulations.

- 8) Candidates have to exercise options for B category and if eligible for C (NRI) in order of their priority for course and college. Allotments will be made according to the order of preference in the web options exercised by the candidate.
- 9) Candidates can exercise options on the web either from home / any other place having internet facility. Candidates are instructed to take a print out of saved options
- 10) One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options.
- 11) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also informed to login to check their allotment status on through <https://tspvtmedadm.tsche.in/> website after each phase of counseling.
- 12) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using online payment method (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment details and report to the Principal of respective college on or before the date specified on the allotment letter.
- 13) Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and the candidate's options shall not be considered for subsequent phases of counselings and admission to prevent seat blocking.
- 14) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.

- 15) Candidates allotted seat under NRI Quota should produce the relevant sponsorship letter from NRI relative in Original along with copy of passport/ Residence Proof/Bank Statement or pass book of sponsor for NRI Category at respective colleges.
- 16) Original certificates submitted at the time of admissions shall not be returned to candidate, unless the candidate discontinues the course before second phase of counseling. If the candidate slides to other college during the second phase of counseling, the original certificates will be transferred to the allotted college.
- 17) Candidates are informed that as per Hon'ble Supreme Court orders and MCC/DGHS, Ministry of Health Government of India notice no. U-12021/01/2022-MEC, dated. 12.07.2022 and in accordance with GO.Ms.No. 109 HM & FW Department, dated. 22.08.2022, admitted candidates are not permitted to withdraw from the course after second phase of counseling. Candidates are also informed that admitted candidates who have joined upto round 2 of All India quota and State Quota shall not be eligible for further rounds of All India Quota and State counselings (Competent Authority Quota and Management Quota).
- 18) Admitted candidates will have to pay discontinuation penalty amount of Rs.20 lakhs as per Government Orders, if they discontinue the course after the second phase of counseling to get their original certificates back.
- 19) The University fee once paid shall not be refunded under any circumstances.
