In continuation to this office notifications dated **07-08-2023 and 24-08-2023** in accordance with Letter No. U12021/07/2023-MEC(Pt.1) Dated: 20.09.2023 from Ministry of Health and Family Welfare Government of India, KNRUHS hereby notifies online registration from NEET-MDS-2023 qualified candidates after reduction of NEET-MDS cutoff score, who have not registered in response to the earlier notifications issued for online registration for admission into under Management Quota into Dental Colleges affiliated to KNR University of Health Sciences including Army Dental College in the State of Telangana.

Notification is issued for online registration for web based counseling to determine State Merit position for admission into **Management Quota** seats only. Provisional Final Merit list will be notified after scrutiny of all certificates uploaded at the time of online registration. Total number of vacant seats available under Management Quota for the academic year 2023-2024 will be notified on KNRUHS website before exercising web options for counseling. Tuition fee payable will be as notified by the Government of Telangana.

Application forms online are invited from NEET-MDS-2023 qualified candidates from Indian Nationals / OCI / NRIs for admission into the MDS courses under Management Quota for the academic year 2023-24 into dental colleges affiliated to KNR University of Health Sciences in the state of Telangana.

Notification is issued for online registration for web based counseling to determine State Merit position for admission into **Management Quota seats** only. Final Merit list will be notified after scrutiny of all Certificates uploaded at the time of online registration. Total number of seats available under Management Quota for the academic year 2023-2024 will be notified on website before exercising web options for counseling. Tuition fee will be as notified by the Government of Telangana in G.O.Ms.No. 107&108 HM&FW (C1) Department, Dated: 28-07-2023.

NOTE: *LOWER PERCENTAGE / PERCENTILE OF MARKS FOR SC/ST/BC/OBC /PWD IS ONLY FOR ELIGIBILITY PURPOSE AND WILL NOT BE APPLICABLE FOR RESERVATIONS AS THERE ARE NO RESERVATIONS UNDER MANAGEMENT QUOTA.

Final Merit position of the applied candidates will be prepared based on NEET - MDS- 2023 Score and other eligibility criteria notified hereunder after verification of uploaded certificates.

1. ELIGIBILITY:

- A) Candidate should have qualified in NEET-MDS-2023 by securing marks of cut-off score or above as displayed above.
- B) Candidate should have passed BDS Degree examination from an Institution recognized by the Dental Council of India.
- C) Candidates who have completed their BDS course from an institution outside the country shall submit permanent registration certificate compulsorily.
- D) Candidates should have registered with Dental Council of India/State Dental Council.

NOTE: The candidates should have completed internship by 30.06.2023 and shall submit Internship Completion Certificate.

2. The NEET-MDS-2023 qualified and eligible candidates as per concerned regulations who desire to take admission into MDS Courses shall apply online and upload all original certificates for determining the Merit position for Telangana State Management quota seats using NEET MDS 2023 ranks in the Website <https://pvttsmds.tsche.in> from **08.00AM on 09-08-2023 to 16-08-2023 up to 5.00PM** . The online application can be filled through any computer with Internet connection.

3. **Registration and Verification Fee for MDS Degree courses** :- The Registration and Verification fee of Rs. 6300/- (Bank transaction charges extra) shall be paid online through Debit card / Credit card or Net Banking.**

** **Registration and Verification Fee** once paid will not be refunded or adjusted to a further date.

** Candidates are advised to check their eligibility to apply for determining the Merit position for eligibility by using NEET-MDS-2023 score by reading Prospectus / Regulations carefully.

Candidates who completed BDS from other States must pay equivalency fee verification of certificate along with the **Registration and Verification Fee**. The fee for BDS Degree from otherstate or other country is Rs. 5,000 & Rs. 7,000 respectively.

- (i) Permanent Dental Registration Certificate is mandatory if the candidate obtained Dental Degree Certificate from outside the country.

(j) Candidates claiming NRI quota (MQ2) Should submit the following documents from a Blood relative such as Father/Mother/Brother/Sister/Uncle/Aunt only and should submit a declaration to that effect.

2. NRI status certificate of the financial supporter issued by embassy of respective country under their seal.

6. Procedure for submission of filled-in online Application form for MDS courses:-

The candidate should submit the print-out of the filled-in online application form and original certificates along with (1) set of self attested copies to the Principal of allotted college at the time of admission for final verification. In case of any discrepancy, the provisional allotment order will be cancelled.

7. MANAGEMENT QUOTA SEATS:

A) MDS seats available under Management Quota in Dental Colleges including Army Dental College will be displayed separately on KNRUHS website before Online Counseling.

B) Final seat matrix for Management Quota sub-category - MQ.-1, MQ.2, MQ-3 will be displayed on KNRUHS website <http://knruhs.telangana.gov.in/> before online counseling.

c) MDS seats in Army Dental College are reserved for wards of Army Personnel Only.

NOTE:

- i) On-online application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area, incomplete applications will be automatically rejected and will not be considered for determining the Merit position using NEET-MDS-2023 score.
- ii) The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
- iii) Candidates may please note that the University will take up the online verification of certificates with regard to eligibility conditions i.e., Educational qualifications, validity of registration with DCI/ State Dental Council, Internship certificate, category status as per uploaded relevant certificates. If the information furnished by the candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deems fit will be taken.
- iv) Eligibility of candidate for admission into MDS courses for the academic year 2023-2024 will be examined by the University only after scrutiny of application along with all copies of required certificates and provisional final merit list will be notified.
- v) **Registration along with uploading of Scanned Original certificates will be done only once irrespective of the number of times of exercising web options / Number of counselings. No separate notification will be given for verification of original certificates. Therefore the candidates should register and upload all the mandatory Certificates without fail.**
- vi) Scrutiny of uploaded Original Certificates shall be done by the University and concerned departmental officials. After scrutiny of application and certificates provisional final merit list will be released. Candidates are advised to refer to KNRUHS website for further details regarding schedule of exercising web options.
- vii) Admissions will be in accordance with the Orders issued from time to time by State Government with regard to process of Admissions to MDS Courses and relevant Hon'ble Supreme Court and Hon'ble High court orders.

- viii) The procedure for preparation of seat matrix and selection into MDS courses in the Management Quota and seat allocation will be done as the procedure given in G.O.Ms.No. 40, 42, HM&FW (C1) Dept., dated: 09-05-2017 and subsequent amendments.
- ix) The notification is for determining the State Merit position using NEET-MDS-2023 Rank only. The dates for exercising web options for admission into MDS courses and procedure will be notified separately on University website. **Candidates are advised to check the University web-site for notifications, schedules and other details from time to time.**
- x) An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
- xi) Admissions will be considered only for candidates, who have secured marks above cutoff score in NEET- MDS-2023 exam and based on the state merit order as the case may be.

REGULATIONS:

The following are the Regulations for admission into MDS Courses under Management Quota for the academic year 2023-24 into Dental Colleges including Army Dental College affiliated to KNR University of Health Sciences in the State of Telangana.

1. Number of seats under Management Quota:

- a. The number of MDS seats to be available for the academic year 2023-24 under Management Quota in MDS courses at Private Dental colleges will be in accordance with the orders of the DCI/GOI/Govt. of Telangana.
- b. The seats for the year 2023-24 will be displayed in the KNRUHS website before exercising web options for counseling.
- c. In case any new seats in MDS Courses are permitted by Government of India in colleges affiliated to the University for the academic year 2023-24, those seats also will be filled up. **NO FURTHER NOTIFICATION WILL BE ISSUED.**

2. ELIGIBILITY:

- a. The candidates who fulfill the following criteria are eligible for admission into MDS courses. They have to apply online and upload the original certificates for Management Quota seats in dental colleges affiliated to Kaloji Narayana Rao University Of Health Sciences, Warangal.
- b. The candidates who have qualified in NEET- MDS – 2023 examination with the following revised cutoff scores and above of National Board of Examinations, New Delhi are eligible to apply.

****Lower percentage / percentile of marks for SC/ST/BC/OBC /PWD is only for eligibility purpose and will not be applicable for reservations as there are no reservation under management quota.***

- i. The Candidates from All over India are eligible for Management Quota Sub – Category – 1.
- ii. NRI / OCI / NRI sponsored candidates are eligible for Management Quota Sub – Category – 2 (NRI Quota)
- iii. Candidates sponsored by the Managements of Private Dental Colleges having MDS Courses in Telangana State are eligible for Management Quota Sub – Category – 3.
- iv. **Army Dental College MDS seats are reserved for wards of army personnel only.**
- v. BDS Degree should be recognized by the Dental Council of India.

VI. BDS Graduates pursuing internship should have completed internship on or before 30-06-2023

- vii. Must have registered with State Dental Council and subject to the fulfillment of the conditions stipulated in Regulations and its documentary proof should be uploaded along with online application.

Note:

- i. If a candidate is found to have submitted false information or concealed any relevant information regarding this matter, such candidate is liable to be disqualified for admission and in case already admitted, the admission will be cancelled. Further disciplinary action against him/her will be taken by the University/respective institution.
- ii. If the candidate is having a Medical qualification equivalent to BDS (Primary Dental qualification) from outside India, the Degree should have been recognized by Dental Council of India for enrolment as Medical Practitioner in the Country.
- iii. Candidate must have registered with Dental Council of India or any State Dental Council.
- iv. Candidates who are already studying P.G. MDS course shall not be permitted for registration for web based counseling unless they discontinue the course by remitting requisite bond amount and stipend drawn up to that date before submitting the application form. Such candidates shall have to upload the certificate issued by the Head of the Institution to that effect along with the online application form.

- v. **Equivalency fee:** Candidates must pay fee for verification of certificates with regard to equivalence / equivalency as specified in the regulations along with the registration fee, in case of obtaining BDS Degree from other state or Other country.
- vi. The Registration fee and Verification fee once paid will not be refunded or adjusted to a future date. Therefore candidates are advised to check eligibility conditions thoroughly before applying for determining merit position in respective categories for State quota seats using NEET-MDS-2023 rank.

3. **ONLINE APPLICATIONS:**

The on-line application form for determining merit position in respective categories (Sub category – 1,2 & 3) for Management Quota seats using NEET–MDS–2023 scores will be available on the website <https://pvttsmlds.tsche.in> from **08.00AM on 09-08-2023 to 16-08-2023 up to 5.00PM.**

Note: The candidates are advised to take a print out of the Prospectus / Instructions to fill the application from the website <http://www.knruhs.telangana.gov.in> or <https://pvttsmlds.tsche.in> before proceeding to fill the application form.

6. EQUIVALENCY FEE FOR CANDIDATES STUDIED OUTSIDE THE STATE AND COUNTRY:

Candidates must pay fee for verification of certificates with regard to equivalence / equivalency as specified in the regulations along with the registration fee, in case of obtaining BDS Degree from other state or Other country of Rs. 5,000 & Rs. 7,000 respectively.

The Registration fee and Verification fee once paid will not be refunded or adjusted to a future date.

Note: The candidature of the applicant will not be considered for admission to MDS courses unless the candidate uploads all relevant scanned Original certificates.

7. MERIT LISTS:

The final merit position of the candidates who have applied online in response to the notification issued by KNRUHS for Management Quota seats shall be determined by NEET – MDS - 2023 RANK and as per their eligibility criteria, applicable regulations, guidelines viz:

- i. As per MDS Regulations of Dental Council of India, the candidates who secure minimum of 50th percentile for general category, 40th percentile for SC/ST/BC candidates and 45th percentile for Persons with disabilities category in NEET-MDS-2023 cutoff scores are eligible for admission into MDS Courses only for the purpose of qualifying criteria as there are no reservations under Management Quota. Any changes in the qualifying score as notified by DCI shall be applicable.
- ii. The University will release final merit list of eligible candidates for exercising web options after verification of uploaded certificates by the University.

Management Quota Seats are allotted as per G.O.Ms.No.40, 42, HM&FW (C1) Dept., dated: 09-05-2017: and subsequent amendments (for rules of admissions).

- a) 50% of seats in each specialty in each college are management quota seats. The Management Quota Seats are categorized into Management Quota (a) Sub – Category – MQ1. 25%, Management Quota (b) Sub – Category – MQ2. 15% NRI quota (NRI/NRI Sponsored) (c) Management Quota Sub – Category – MQ3 Institutional Preference Quota – 10%.
- b) For Management Quota Sub – Category – MQ1 – 25%, candidates from all the states and union territories of India are eligible.
- c) For Management Quota Sub – Category – MQ2 – 15%, NRI candidates, NRI sponsored candidates, OCI card holders and Persons of Indian Origin (PIO) are eligible.
- d) For Management Quota Sub – Category – MQ3 – 10%, candidates sponsored by the Management's of the Private Dental Colleges having Post Graduate Course in the State of Telangana.

Note: I. The eligibility criteria for sub category MQ3 in an institution is as follows.

1. Candidate completed BDS from that institution
2. Candidate is an employee of that institution
3. Candidate is the son / daughter of employee of that institution

II. The Eligibility criteria for NRI (MQ2) Quota is as follows:

- i) Admission to NRI seats will be made on the basis of NEET-MDS-2023 merit ranks of eligible candidates who have applied on-line for NRI seats.
- ii) NRI Financially supporting the candidate must be a Blood relative such as Father/Mother/Brother/Sister/Uncle/Aunt only and should submit a declaration to that effect.
- iii) Candidate opting for NRI seat must furnish the photocopies of following supporting documents.

8. UNIVERSITY FEE:

1. Allotted candidates have to pay the following University fee through payment gate way for downloading the allotment order

MQ 1 Management Quota sub category 1: Rs.49,600/-

MQ2 (NRI) & MQ3 (Institutional Quota) : Rs.69,600/-

2. Tuition Fee as notified by the Government
3. The candidates selected into MDS course shall work for one year as "Senior Resident" in the Institution where they pursued the course.

NOTE: CANDIDATES WHO HAVE APPLIED ONLINE IN RESPONSE TO THIS OFFICE NOTIFICATION FOR DETERMINING MERIT POSITION FOR MANAGEMENT QUOTA SEATS SHALL UPLOAD THE CERTIFICATES ONLINE ALONG WITH THE APPLICATION. 9. COUNSELING:

The notification for schedule for exercising web options will be issued separately on KNRUHS website. Verification of uploaded certificates will be done only once for web based counseling irrespective of number of rounds of exercising web based options and number of counselings. Hence, candidates who have applied on-line are advised to upload all original certificates at the time of online registrations without fail for scrutiny by University. No individual communications will be sent. Candidates are informed to check the website regularly for notifications.

The Admission Committee shall have power to review the selection in case of any errors, misrepresentation or glaring injustice and cancel the selection/admission. In all matters relating to selection and admissions, the decision of the Admission Committee shall be final and binding on the Candidates and selections cannot be questioned after admissions are closed.

10. ADMISSION RULES:

10.1. The letter of selection of admission for selected candidates has to be downloaded from the website after payment of University fee through payment gateway.

All the candidates joining the MDS courses shall execute bond on a stamped paper of Rs. 100/- as prescribed in Annexure-II to the effect that he / she will complete the prescribed period of training or in default to pay **Rs.5,00,000/- (Rupees Five Lakhs only)** to the University.

10.1.1 **Bond for service after completion of degree** : Candidate shall submit a bond for serving the State of Telangana as per existing Government Regulations at the time of admission.

10.2 The candidates who discontinue the course after issue of notification for final round of counseling or later will have to pay discontinuation fee of **Rs.5,00,000/- (Rupees Five Lakhs only)** They will be debarred from participating in counseling's for admission into MDS for a period of three(3) years under KNR UHS.

10.3 The original certificates submitted at the time of admission to the Principal of the allotted college shall not be returned to the candidates until they complete their course.

10.4 Attendance: Candidates selected for the various courses should be whole time students. The candidate is required to put in a minimum of 80% attendance during each calendar year for being eligible to appear for the examination.

In a year all 365 days will be considered as working days and students should get 80% attendance each year separately to get eligibility for appearing for University exams. The remaining days of absence (including maternity leave) will be considered for extension.

10.5 Leave: Each year students will be permitted to avail 30 days leave. No Post Graduate is allowed to go on leave for more than 10 days at a stretch. In-case the absence of the candidate availing Medical Leave / Maternity Leave / Any

other Leave or unauthorized absence is beyond 30 days in a year the study period of the candidate will be extended to the extent of such period. No other leave is permitted.

10.6 Maternity Leave: Women students can avail maternity leave upto 180 days only once in their MDS course of study and the study period will be extended to the extent of Maternity leave availed. The candidate shall not be eligible to appear in the University examination till the completion of study period as per MCI/DCI Regulations (Duration of course).

10.7 Break of study and re-admission:

- a. Every candidate after his admission shall attend classes on all working days (Theory, Practical's, Clinicals). If a student absents continuously for a period of 91 days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.
- b. If the break of study (91 days are more) in more than one spell, the candidate's representation in the prescribed proforma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the University.
- c. Candidates who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission in to the course and the studentship stands cancel without any further notice.
- d. The candidate has to pass the final examination for award of Degree for the course within double the duration of study period for the course or within the maximum period permitted by the National Medical Commission from time to time.

10.8 Private Practice: No Post Graduate is allowed to do any private practice or consultation and should not accept any part time employment in any State or central or Quasi Government or private organizations during the period of Post Graduate study. The Principal has to take appropriate action after giving opportunity for explanation, if any student violates this rule.

10.9 College Regulations: Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal.

11. CLOSURE OF ADMISSIONS:

11.1 The admissions shall be closed as per the time schedule given by the DCI.

11.2 Any vacancy that arises after closure of admissions shall not be filled.

12. PERIOD OF TRAINING: The duration of MDS Course is 3 Years. A candidate admitted into MDS course shall pass the examination within 4 years from the date of completion of the course. If he/she fails to pass the examination within the period specified above, he/she shall not be permitted to appear for the examination thereafter and qualify for the award of MDS Degree.

13. COMMENCEMENT OF THE COURSE: The course shall commence as per the schedule notified. The duration of the course shall be calculated from the date of commencement of the course and shall be uniform for all the candidates irrespective of individual dates of admission.

14. POWERS OF THE PRINCIPAL: Notwithstanding anything contained in these regulations, the Principal may, at any time before completion of the Post Graduate course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause **notice to** submit a written explanation and or on a personal hearing, order the cancellation of admission to the course, if in his opinion, such candidate had furnished incorrect particulars or false information in the application form or in the documents

attached thereto or in the Statements made either before the authority In- charge of admissions or the Principal or any other manner. Against any such order of the

Principal, an appeal shall lie to the Registrar, KNR University of Health Sciences, TELANGANA.

15. POWERS OF THE KNR UNIVERSITY OF HEALTH SCIENCES: KNR University of Health Sciences, may either suo motu or on an application made to them, call for and examine the records relating to any selection or admission or cancellation thereof in respect of the admission made by the concerned authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation thereto as they deem fit including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation. University has every right to cancel the admission of any candidate without any notice, if the certificates produced by the candidate are found to be fake / false/forged.

16. Discipline:

The students shall maintain strict discipline during the period of study/training program. The candidates shall not resort to any strikes during the period of their study. The students are not permitted in criticizing the policies of the Institute/University either before the print or electronic media or anywhere which amounts to dereliction of duties. Their grievances (if any) may be submitted to the Dean/Principal through proper channel. They are not permitted to approach the legal authorities/ DCI/Govt. without prior permission by the Institution and University. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond.

17. Ragging:

Ragging is prohibited in the Educational Institutions of State of Telangana and students shall not involve in ragging which may lead to serious consequences including cancellation of seat and punishments as per law.
