NOTIFICATION FOR ADMISSION INTO BHMS COURSE FOR 2024-25 UNDER ALL INDIA QUOTA (AIQ) IN THE STATE OF TELANGANA IN PRIVATE HOMOEOPATHIC COLLEGES AFFILIATED TO KNRUHS.

Applications online are invited for **All India Quota admissions** from National Eligibility-cum- Entrance Test (NEET) UG – 2024 qualified candidates for admission into BHMS course for the academic year 2024-25 in Private Homoeo colleges affiliated to KNRUHS, Warangal in the State of Telangana.

Notification is issued for online registration, uploading of scanned original certificates and exercising web-options for admission into All India Quota seats (i.e., 15% of intake of seats) from Private Homoeo Colleges affiliated to KNRUHS.

Provisional final Merit position of the applied candidates will be prepared based on the NEET UG - 2024 Rank and other eligibility criteria notified hereunder after verification of scanned original certificates and allotments will be done based on options exercised from eligible candidates. Final Verification of original certificates will also be conducted at the time of admission at allotted college by Admission Committee.

1. ELIGIBILITY :

- A. Candidates, who have qualified in NEET- UG -2024 by securing the following marks of cutoff score or above have to apply for online registration and exercising options for **All India Quota** seats.

Minimum Qualifying Scores in NEET- UG- 2024 for UG AYUSH courses :

Candidates should have secured the following cutoff score or above in NEET- UG-2024.

Category	Qualifying Criteria	Cut off score
General category including EWS	50 th Percentile	162
SC/ST/BC & PWD Candidates	40 th Percentile	127
Persons with Disability, PWD (OC)	45 th Percentile	144

Note: Cutoff score of OC PWD/ BC / SC / ST is only for purpose of eligibility for admission. There is no reservation for All India Quota (AIQ).

B. The details of required qualifications for different categories are as follows:

- i. The candidate must have passed Intermediate (10+2) or its equivalent examination recognized by the concerned State Government and Education Board with the subjects of Physics, Chemistry, Biology and English individually.
- ii. Minimum of 50% marks taken together in Physics, Chemistry and Biology at the aforesaid qualifying examination in the case of General Category.
- iii. Minimum of 40% marks taken together in Physics, Chemistry and Biology at the aforesaid qualifying examination in the case of the Scheduled Castes, Scheduled Tribes and other Backward Classes including PWD candidates of these categories.
- iv. Minimum of 45% marks taken together in Physics, Chemistry and Biology at the aforesaid qualifying examination in the case of PWD candidates of General Category.

C. **AGE:** The Candidate should have completed 17 years of age as on 31-12- 2024. The candidates who do not complete 17 years as on 31- 12-2024 are not eligible for admission.

NOTE: Age shall be calculated on the basis of date of birth as mentioned in the Secondary School Certificate.

3. The NEET UG 2024 qualified and eligible candidates as per the concerned regulations who desire to take admission into in All India Quota BHMS Course in Private Homoeo Colleges shall apply online and upload all original certificates for determining the Merit position for **ALL INDIA QUOTA SEATS** and exercise web options at the time of registration itself. The online application can be filled through any computer with internet connection. **(NOTE: PREFERBLY DESKTOP OR LAPTOP)**
4. **Registration and Verification Fee for BHMS Course:-** The Registration and verification fee is **Rs.2,000/-** (Bank transaction charges extra) for OC, BC, SC & ST category candidates (Bank transaction charges extra). Fee shall be paid online through Debit card / Credit card or Net Banking.**
- ** Registration and verification fee once paid is not refundable**
5. **University Fee :** Allotted Candidates have to pay University fee of **Rs. 8,000/-** for BHMS Course through payment gateway by using online payment method. **(Debit Card/Credit Card/Internet Banking)** and download the allotment letter.
6. Candidates admitted in 2nd phase of All India Quota counseling are not permitted to leave/surrender the seat after joining the course. They are permitted to leave /Surrender the seat till the last date of free exit notified by KNRUHS on website with forfeiture of the University and College fee. If the candidate cancels the admission/ discontinues the course after the last date for free exit, candidate have to pay a penalty of **Rs. 1,00,000/-** in addition as per State Government order and they will not be eligible for BHMS admission under KNRUHS for 3 years.

7. **As per Ministry of AYUSH Guidelines for allotment of AIQ UG seats in Private ASU & H Institutes: All AIQ UG seats of Private Homoeo colleges are open in nature. However, relaxation in qualifying criterion may be considered category wise as mentioned above. Candidates domicile certificate is not required for allotment of All India Quota seats in Private AYUSH colleges.**
8. **Procedure of filling online application and online payment for BHMS Course**
 - i. The registration fee can be paid through Debit card / Credit card or Net Banking.
 - ii. The registration fee paid by the applicants is not refundable under any circumstances.
 - iii. Visit website through Computer with Internet connection to fill the application form.
 - iv. Registration number sent to the registered mobile after entering the basic data should be noted for further use. The Registration number should be kept confidential and not to be disclosed to others.
9. **The following Documents are required (PDF format):**
 - a. Admit card of NEET UG - 2024
 - b. Rank card of NEET UG-2024
 - c. SSC or equivalent examination containing the Date of Birth
 - d. Memorandum of marks of qualifying examination i.e., Intermediate or Equivalent examination.
 - e. Latest Permanent Caste Certificate (Integrated Community Certificate) for BC/SC/ST Categories issued by competent authority of their respective State. **(For cut off score relaxation in eligibility criteria)**
 - f. Aadhar Card
10. **Undertaking in the form of Affidavit shall be submitted at the time of admission by the Parent and candidate stating that the submitted certificates are genuine and they will be held responsible for any further consequences as per law if any discrepancy noticed.**

11. **Important information for candidates:-**

- a) **Visit website through Computer with Internet connection to fill the application form.**
- b) Fill in all the details in the online application form and upload all the documents which are mandatory and exercise options for BHMS course to the colleges in which you are interested as per your priority.
- c) Online application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area, incomplete applications and applications without options for colleges will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2024 rank and allotment.
- d) The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by candidate in the online application are accepted as true and correct.
- e) Candidates may please note that the University will take up the verification of original certificates with regard to eligibility conditions i.e., NEET UG-2024 Rank and other details as per uploaded relevant certificates by the concerned department officials. If the information furnished by the candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deemed fit will be taken.
- f) University shall make allotments as per one time options exercised by candidates. Candidates are advised to refer to KNRUHS website for allotment details. No individual communication will be sent. In case of any vacancies after first phase of counseling the same options shall be considered for second phase. Any vacant seats after 2nd phase of counseling are reverted to State Quota.
- g) Candidates are informed that if an admitted candidate (of 1st phase) is allotted a seat in the 2nd phase of counseling as per his/her priority of options, the seat allotted in the 1st phase is automatically vacated and allotted to the next meritorious candidate.
- h) Admissions will be in accordance with the Government Orders and University Regulations. Candidates are directed to read the Regulations and Prospectus for admission into UG AYUSH courses notified on KNRUHS website.

- i) After allotment candidate will receive SMS of allotment. Allotment list will also be displayed on KNRUHS website. Candidates are directed to check KNRUHS website for allotment notification without fail.
- j) Allotted candidates should download the allotment order on payment of University Fee by payment gate way, check the details of allotment and report to the Principal of allotted college before the last date mentioned in the allotment letter. If the candidate fails to get admitted after allotment in the 1st phase of counseling, the candidate will not be eligible for 2nd phase of counseling.
- k) Candidates shall submit the printout of the filled-in online application form, allotment order, Bonds and original certificates along with (1) set of self attested copies to the Principal of allotted college.
- l) Candidate has to pay the College fee and Tuition fee at the time of joining. The Admission Committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.
- m) Tuition Fee is Rs. 40,000/- per annum as notified in G.O.Ms.No. 168, Health, Medical & Family Welfare (E1) Department Dated: 09-09-2017, issued by Government of Telangana.
