PG MEDICAL ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA - 2024-25 Notification for exercising web-options for Mop Up phase of counselling

In continuation to this office earlier notifications and 31-01-2025, KNRUHS hereby notifies the conduct of Mop up phase of web-based counseling for allotment of the PG non-service quota seats under Competent Authority Quota for 2024-25.

Candidates whose names are notified in the revised Provisional Final Merit list of PG Medical Admissions on the KNRUHS website on 31-01-2025 are eligible to exercise web-options online from computer with internet connection subject to following conditions:

- 1. The Candidates who were allotted seats under Competent Authority Quota in the previous phases of counseling and have not reported/discontinued the course after joining at the respective college are not eligible for exercising web-options.
- 2. Candidates who have not exercised web options in the first phase of counseling are also not eligible to exercise web options.
- 3. The candidates who were allotted PG Medical seats in the previous phases of counseling and joined the course and continuing in the course are eligible to exercise web options.
- 4. Candidates who are admitted under All India Quota after 3rd round are directed not to exercise web options.

Eligible candidates can exercise web options as per eligibility for admission into vacant PG Medical Non-service Quota seats from <u>02.00 P.M. on 01-02-2025 to 02.00 P.M.</u> <u>on 03-02-2025</u> through website <u>https://tspgmed.tsche.in</u>

For eligibility criteria and regulations refer to notifications dated: 30-10-2024

UNIVERSITY FEE: Allotted Candidates have to pay University fee of Rs.29,600/by way of online payment gate-way and download the allotment
letter. Candidates who have already paid University fee in

previous phase need not pay again.

UITION FEE:

Tuition fee is to be paid at respective Medical colleges. The tuition fee payable as notified by Government of Telangana in G.O.Ms. No. 107 HM& FW(C1) Dept. Dated: 28.07.2023 (notified on website).

The allotment of seats will be made in accordance with the existing Government orders and relevant Hon'ble Supreme Court and Hon'ble High Court orders.

IMPORTANT NOTE: All the candidates are hereby informed that the allotments and admissions are subject to the orders of Hon'ble Supreme Court and Hon'ble High Court in pending cases.

Instructions to Candidates:

- 1) The details of vacant seats (seat matrix) including seats reverted from service quota are placed in the website http://knruhs.telangana.gov.in. Candidates can exercise web options for vacant seats in all Medical Colleges affiliated to KNRUHS through https://tspgmed.tsche.in as per eligibility.
- 2) Competent Authority Quota seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Competent Authority Quota seats in other Medical Colleges.
- 3) Candidates are advised to go through the prospectus of KNRUHS and the Government orders on Rules of PG admissions available on website before exercising web options for the regulations.
- 4) Candidates exercising web-options for PG Medical courses are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of subjects and colleges the candidate is interested to join as per candidate's eligibility.
- 5) Candidates are advised to exercise web options for PG seats in all courses and colleges in which they are interested to join irrespective of available vacant seats shown in the seat matrix, as vacancies may arise during counseling process due to sliding of candidates from allotted seats in previous phases of counseling to other seats as per their web options in the Mop up phase of counseling. If candidates are

- not interested to join in any subject or college, they should not exercise web options for the same.
- 6) If a PG seat is allotted in this phase of counseling as per web options exercised by the candidate, the seat allotted in previous phase of counseling will be automatically cancelled and allotted to the other candidate. Therefore, the candidates are informed to exercise web options carefully for sliding with awareness of this fact.
- 7) Candidates can exercise options on the web through a computer either from home / any other place having internet facility.
- 8) One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options.
- 9) Candidates are instructed to take a print out of saved options.
- 10) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also directed to check their allotment status on https://tspgmed.tsche.in website after each phase of counseling without fail.
- 11) The selected candidates shall download the allotment letter from website after payment of the University fee by payment gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment details and report to the Principal of respective Medical College on or before the last date specified on the allotment letter.
- 12) Selected candidates have to report at the respective Medical Colleges before the last date for joining as specified on the allotment letter, submit all original certificates, the relevant bonds and pay the tuition fee / college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within the specified date, the admission will be cancelled automatically.
- 13) If the candidate slides to other college during Mop up phase of counseling, the candidates have to get relieved from previous phase joined college, collect custodian certificate, fees and report to the Principal of allotted college before last date of joining.

14) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional

allotment will be cancelled and action may be initiated as per University Regulations.

- **15**) As informed earlier, admitted candidates are not permitted to withdraw from the course after free exit on 30-01-2025.
- 16) The University fee and other fees once paid shall not be refunded under any circumstances.
