This Notification is issued for registration of the candidates to appear for **Super Speciality** Regular Examinations commencing from **18.03.2025**.

## 1. <u>ELIGIBILITY TO APPEAR FOR SUPER SPECIALITY EXAMINATIONS</u>, <u>MARCH 2025</u>:

The Super Speciality students who are admitted into the Medical Colleges of Telangana State, whose admissions are approved by the KNRUHS during the academic year 2021-22 and also the backlog students who have failed, detained and not registered for the said exams conducted earlier, who have completed three years of study period including period of examinations are eligible to appear for the Super Speciality Examinations in March 2025. A student with 80 per cent attendance of working days (i.e. 751 days of 939 days) is eligible for appearing in the examination. However, period of training will be extended by the same number of days for which maternity/paternity leave and total excess casual leave have been availed in three years.

- 2. The Cut-off date for calculation of attendance percentage of the students is up to 12.02.2025.
- 3. The uploading of the attendance percentage of the students is from **17.02.2025 to 19.02.2025.**
- 4. The confirmation date for uploaded attendance percentage of the students is on **22.02.2025.**

- A post-graduate student of a degree course in broad specialty/super specialty will do at least one of the following to make him/her eligible to appear in his/her final examination:
  - a. Poster presentation at a National/Zonal/State conference of his/her speciality;
  - b. Podium presentation at a National/Zonal/State conference of his/her speciality;
  - c. Have one research paper published/accepted for publication in journal of his/her speciality as first author

# DIGITAL VALUATION AND PROVIDING ONLY SINGLE ANSWER BOOKLET WITHOUT ADDITIONAL ANSWER BOOKLET:

The University is a Digital campus and implementing digital valuation for all courses. For Super Speciality course, a single answer booklet with candidate specific bar code on each page will be issued to the candidates appearing for examinations and no additional answer booklet will be issued to the candidates. The candidates should answer all the questions in the single answer booklet only.

#### Valuation:

All the answer scripts shall be subjected for two valuations by the University. The average of the total marks awarded by the two valuators for the paper, which is rounded off to the nearest integer (whole number), shall be considered for computation of the results. All the answer scripts, where the difference between two valuations is 15% and more of the total marks prescribed for the paper, shall be subjected to third valuation. The average of the best two total marks, awarded by the three evaluators for the paper, rounded off to the nearest integer (whole number), shall be considered for final computation of the results.

- As per NMC Regulations, the candidate shall secure not less than 50% marks in each head of passing which shall include:
  - 1) Theory aggregate 50% (In addition, in each Theory paper, a candidate has to secure minimum of 40%)
  - 2) Practical/Clinical and Viva voce aggregate 50%

Hence, the minimum pass marks in theory are as follows:

- a) 40% marks in each paper separately i.e., 40/100 (Forty out of Hundred)
- b) 50% marks cumulatively in all the four papers of theory exam i.e., 200/400. (Two Hundred out of Four Hundred)
- ➤ No grace mark is permitted in Super Speciality examination either for theory or for practical.
