This notification is issued for registration of the candidates to appear for MD/MS Ayurveda Part II Regular Examinations commencing from **15.03.2025**.

#### 1) Eligibility to appear for MD/MS Ayurveda Part II Regular Examinations:

The MD/MS Ayurveda students admitted by the KNRUHS during the academic year **2021-22** whose admissions are approved by the University and completed study period with **75% attendance** (both theory & practical separately) in each subject and also the students of previous batches who have failed, detained and not registered for the said examinations conducted earlier are eligible to appear for the examinations in March 2025 subject to the course regulations.

- 2) The Cut-off date for calculation of attendance percentage of the students is up to 10.02.2025.
- 3) The uploading of the attendance and internal assessment marks of the students is from 17.02.2025 to 19.02.2025.
- 4) The confirmation date for uploaded attendance and internal assessment marks of the students is on 22.02.2025.
