**Admission into Nurse Practitioner in Critical Care Course through Computer based (online)  
Entrance Test for the year 2024-25**

Application forms through online are hereby invited from the eligible candidates for admission into NPCC Course through Computer based online Entrance Test for the year **2024-25** for the seats in institutes affiliated to Kaloji Narayana Rao University of Health Sciences, Warangal.

1	The candidate desiring to appear for Entrance Test for admission into NPCC Course shall apply through Online on the website <a href="http://knruhs.telangana.gov.in">http://knruhs.telangana.gov.in</a> from <b>24.02.2025, 10.00 A.M to 03.03.2025, 5.00 P.M only</b> . The online application can be filled through any computer with internet connection (home/internet café/net center)
2	For Other details read the Prospectus carefully. The Prospectus of the courses, instructions, for filling online Application and sample of filled – in Application is also available on the University Website <a href="http://knruhs.telangana.gov.in">http://knruhs.telangana.gov.in</a>
3	<b>Registration/Entrance Test/Counselling Fee:</b> The registration & counselling fee is Rs. 4,000/- (Bank transaction charges extra) for OC/BC categories and Rs.3,000/- (Bank transaction charges extra) for SC/ST categories.
4	<b>Verification Fee :</b> The candidates who acquired their B.Sc.(N) Degree outside the State applying for Entrance Test for admission into NPCC course under this University, shall pay a verification fee Rs.5,000/- for the degree acquired outside the State.

**3. Eligibility for Admission into NPCC course:**

**ELIGIBILITY CRITERIA FOR COMPETENT AUTHORITY QUOTA:**

(as per G.O. Ms. No. 150 HM&FW(C1) Dept., dated 28-10-2024)

**Nationality & Domicile:**

The Candidate for admission into Nurse Practitioner Critical Care courses should be Indian National, Person of Indian Origin/Overseas Citizen of India card holder and shall be a local candidate:

(i) The seats earmarked as Convenor (Government) Quota, shall be reserved and filled up by the local candidates from the common merit list of the entrance test.

(ii) 'Local candidate' means a candidate who has studied in the Educational Institutions in the state of Telangana as for a period of not less than four (4) consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in the relevant qualifying examination.

The Candidates must satisfy the INC eligibility criteria as below:

1)	Educational Qualification	<p>a. Applicants must possess a registered B.Sc nurse with a minimum of one year clinical experience, preferably in any critical care setting prior to enrollment.</p> <p>b. Must have undergone the BScNursing in an institution found suitable by the Indian Nursing Council and have been registered in any State Nursing Council</p> <p>c. Must have scored not less than 55% aggregate marks in the BSc program</p> <p>d. In-service candidates will get regular salary</p> <p>e. Salary for the other candidates as per the salary structure of the hospital where the course is conducted</p> <p>f. All other candidates should be Indian National and should satisfy Local candidate status as per G.O.Ms. No. 150, HM&amp;FW (C1) Department, dated 28.10.2024.</p>
2)	Entrance Test for both competent authority quota (CQ) & Management Quota (MQ)	Must have secured not less than 40% marks in the entrance test. In case of SC and ST candidates, minimum marks shall be not less than 30% marks.
3)	Physical Fitness	The Candidates shall be medically fit.
4)	<p><b><u>Entrance Test Centre:</u></b></p> <p>The Entrance test will be conducted on 16.03.2025 <b>from 2.30 PM to 4.00 PM</b> at a Centre in <b>Hyderabad</b>. The Details of the Centre shall be provided in the HALL TICKET.</p>	
5)	<p><b><u>Download of Hall Tickets:</u></b></p> <p>The eligible candidate shall download the hall ticket through online from <b>12.03.2025</b> from the link provided in the website <a href="http://knruhs.telangana.gov.in">http://knruhs.telangana.gov.in</a>, by entering his/her application number and date of birth in (DD/MM/YYYY) format.</p>	
6)	<p><b><u>Date and Time of Computer based entrance test:</u></b></p> <p><b>16.03.2025 from 2.30 PM to 4.00 PM</b></p> <p>Reporting time at the entrance test center: 1.30 PM sharp</p>
