

## KALOJI NARAYANA RAO UNIVERSITY OF HEALTH SCIENCES, TELANGANA POST GRADUATE MEDICAL ADMISSIONS UNDER MANAGEMENT QUOTA - 2024-25 NOTIFICATION FOR EXERCISING WEB OPTIONS FOR FINAL STRAY VACANCY PHASE

In continuation to this office earlier notifications and 13-03-2025, KNRUHS hereby notifies the conduct of Final Stray Vacancy phase of web-based counseling for allotment of the vacant PG seats under Management Quota MQ1 and NRI quota for admission into PG Medical courses for the academic year 2024-25 in Private Unaided Non-Minority and Minority Medical colleges affiliated to KNRUHS.

The candidates whose names are notified in the updated provisional final merit list for PG Medical admissions on the website of KNRUHS, Warangal on 12-03-2025 (after 2nd time reduction of cut-off score) are eligible to exercise web-options online from computer with internet connection subject to following conditions:

- 1. The Candidates who were allotted seats in the previous phases of counseling under Management Quota are not eligible for exercising options.
- 2. Candidates who have not exercised web options in the first phase of counseling under Management Quota are also not eligible to exercise web options in accordance with the Government orders.
- 3. Candidates who are notified in the admitted candidates list upto Stray Vacancy phase of Counselling and allotted candidates in Special Stray Vacancy round under MCC counselling are not eligible to exercise web options.
- 4. Candidates who are admitted under Competent Authority Quota and candidates who are allotted seats in Special/Final Stray Vacancy phase of counselling are also not eligible to exercise web options.
- 5. Any candidate who is admitted into any PG Medical course in any medical college in the country is advised not to exercise web options as it amounts to seat blocking.
- 6. If any candidate violates this and the same is noticed by the University at any stage/at a later date, the admission stands cancelled automatically and the candidate is liable for punishment as per law.

All the eligible candidates whose names are displayed in the Provisional final merit list for PG Medical Degree/ Diploma admissions can exercise from **06.00 PM on 19-03-2025 to 10.00 AM on 20-03-2025** 

Candidates shall exercise web options for vacant Post Graduate Medical seats as per their registration and eligibility for MQ-1, MQ-2 (NRI) categories, in order of their priority through <a href="https://pvttspgmed.tsche.in">https://pvttspgmed.tsche.in</a>.

Allotment of seats will be done accordingly. Candidates are informed that they will be considered only to the category / categories to which they have registered.

For eligibility criteria and regulations refer to notifications dated: 09-11-2024.

**UNIVERSITY FEE:** Allotted Candidates have to pay University fee of by way of

payment gate-way online and download the allotment letter.

MQ1 Management Quota sub-category 1: Rs.49,600/-

MQ2 (NRI) & MQ3 (Institutional Quota): Rs.69,600/-

**TUITION FEE:** Tuition fee is to be paid at respective Medical colleges. The Tuition

fee payable shall be as notified by Government of Telangana

## **IMPORTANT NOTE:**

1. The details of vacant seats available (seat matrix) in all Medical Colleges affiliated to KNRUHS will be placed in the website <a href="http://knruhs.telangana.gov.in">http://knruhs.telangana.gov.in</a> The candidates can exercise web options for PG Medical Degree/Diploma seats under KNRUHS through <a href="https://pvttspgmed.tsche.in">https://pvttspgmed.tsche.in</a>.

2. Candidates who are willing to join in the course after allotment on 20-03-2025 (last date of reporting) without fail only shall exercise web options for available vacant seats

## **INSTRUCTIONS TO CANDIDATES:**

- 1) Eligible NEET-PG-2024 qualified Candidates as per provisional final merit list for Management Quota can exercise web options for PG seats in all Medical colleges as per their interest and priority for MQ1 and NRI categories (as per eligibility).
- 2) Candidates are advised to go through the Prospectus for the Regulations for PG courses of KNRUHS, available on website before exercising web options.
- 3) Candidates exercising web options for PG seats are informed that, there is no limit of choices (number) for exercising web-options, candidates can exercise options for any number of subjects and colleges the candidate is interested to join as per eligibility

- and registration. If they are not interested to join in any subject or college then they should not exercise options for the same.
- 4) Management Quota MQ-1 & MQ-2 (NRI) seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Management Quota seats in other Medical Colleges. If Minority candidates are not available, the seats will be allotted to Non-Minority students.
- 5) Candidates have to exercise options for MQ1 and if eligible for MQ2 (NRI) in order of their priority for course and college. Allotments will be made according to the order of preference in the web options exercised by the candidate. Candidates have to exercise options very carefully as per their priority.
- 6) Candidates are informed that if they exercise web-options for a seat and allotted a seat as per their choice in the web- counseling and if they do not join the course at the allotted college, the admission will be cancelled automatically and the candidate will be considered as being part of seat blocking and candidate has to pay penalty of Rs. 50 lakhs and also debarred for 3 years for PG Medical admissions under KNRUHS to prevent seat blocking.
- 7) Candidates can exercise options on the web either from home / any other place having internet facility.
- 8) Candidates can exercise web options through a computer either from home / any other place having internet facility. Don't use mobiles and Tabs for exercising web options.
- 9) One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options.
- 10) Candidates are instructed to take a print out of saved options. Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also directed to check their allotment status on portal/website <a href="https://pvttspgmed.tsche.in">https://pvttspgmed.tsche.in</a> without fail.
- 11) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using Online payment method. (Debit Card/Credit Card/Internet Banking), check their allotment and report to the Principal of allotted college on or before the date specified on the allotment letter.
- **12)** Candidates are hereby informed that final verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.

13) Selected candidates have to report at the respective colleges before the last date for

joining as specified in the allotment letter, submit all original certificates, relevant

bonds and pay the tuition fee / college fee to complete the process of admission. If the

candidate does not fulfill the above criteria to complete the admission process within

the specified date the admission will be cancelled automatically and the candidate

will be considered as being part of seat blocking and candidate has to pay penalty of

Rs. 50 lakhs and also debarred for 3 years for PG Medical admission under KNRUHS

to prevent seat blocking.

14) Candidates allotted seat under NRI Quota should produce the relevant sponsorship

letter from NRI relative in Original along with copy of passport/ Residence

Proof/Bank Statement or pass book of sponsor for NRI Category at respective

colleges.

15) As already notified admitted candidates are not permitted to withdraw from the

course after the last date of free exit (16-02-2025 by 3.00 PM). Original certificates

will not be returned to the candidate, unless the candidate discontinues the course

and fulfills the conditions of the penalty clause as detailed above.

**16)** The University fee once paid shall not be refunded under any circumstances.
