1) <u>Eligibility to appear for MD/MS Avurveda First Summative Assessment Regular Examinations:</u>

The MD/MS Ayurveda students admitted by the KNRUHS during the academic year 2024-25 whose admissions are approved by the University and completed study period with minimum 80% attendance in each subject and minimum 60% Semester Grade Point Average (SGPA) in the first semester are eligible to appear for the examinations in May 2025 subject to the course regulations.

- 2) The Cut-off date for calculation of attendance percentage of the students is up to 11.04.2025.
- 3) The uploading of the attendance and SGPA of the students is from 16.04.2025 to 17.04.2025.
- 4) The confirmation date for uploaded attendance and SGPA of the students is on 20.04.2025.

5) <u>Digital valuation and providing only single answer booklet without additional answer booklet:</u>

The University is a digital campus and implementing digital valuation for all courses. For MD/MS Ayurveda course, single answer booklet with candidate specific bar code on each page will be issued to the candidates appearing for examinations and no additional answer book will be issued to the candidates. The candidates should answer all the questions in the single answer booklet only.
